

Application Terms & Conditions

1. I am of legal age in the state of my residency. I agree that as an Independent Contractor, I am responsible for determining my own business activities and I am not an agent or employee of Nature's Youth LLC. I will not represent in any manner that I am an agent or employee of the Company. I am responsible for the payment of all federal and state self-employment taxes and any other tax required under any federal, state or regulatory agency. I am responsible to pay all sales taxes.

2. I understand that this does not constitute the sale of a franchise and no fee or initial purchase for participation as a Distributor has been required of me.

3. I agree that as a Distributor, I shall place the primary emphasis upon the sale of company products, and agree that over 70% of all my sales will be to non-Distributors. Distributors resident in the states of Maine, North Dakota, Michigan, Indiana, Iowa, and West Virginia are limited to \$495.00 in sales aid(s) purchases from the Company, during the first six months of Distributor status. Permissible sales aids purchase requirements shall be automatically modified to comply with the exemption requirements set forth in any states' laws regulating business opportunities.

4. I will not make false or misleading statements about products or the Distributor Position, and I understand that false or misleading statements to make a product sale or to enlist Distributors into my group will result in my termination. In presenting Company products, services, marketing plan and the Distributor position to prospects, I agree that such presentations shall be strictly according to the following format and that I will be terminated as a Distributor if I fail to do so:

(a) In each presentation of the Distributor position, the prospects shall be directly informed that no payment or purchase is required or is a means to become a Distributor.

(b) The prospect shall receive a complete product presentation prior to any discussion whatsoever concerning the Distributor position.

(c) The solicitation of a product purchase shall not be undertaken, directly or indirectly or at any time, based on the premise that a product purchase may or will be paid for, in whole or in part, by earnings obtained as a Distributor

5. I understand that no attorney general or other regulatory authority ever reviews, endorses or approves any product, compensation program or company, and I will make no such claim to others.

6. I understand that my Distributor position can be inherited or bequeathed, but cannot be transferred or assigned during my lifetime without written consent of the Company, which will not be unreasonably withheld. Six months of inactivity as a Distributor shall result in automatic termination of Distributor status.

7. This Agreement shall be deemed in effect upon its receipt and acceptance by Company at its home office.

8. In order to maintain a viable Marketing Program and to comply with changes in federal, state or local laws in economic conditions, Company may provide Policies and Procedures for Distributor and the Distributor Compensation Program. Such Policies and Procedures, Compensation Plan, and all changes thereto, shall upon notice to the Distributor, become a binding part of this Agreement, upon publication in the official Distributor Newsletter, or the posting upon the Company's web site on the Internet.

9. I will not promote my Distributor business nor use the Company name, or the trade names, logos, sales materials, trademarks or service marks of the Company, except in materials provided by the Company or approved in writing by the Company prior to their use by me. I understand that unauthorized use or duplication of trademarks or copyrighted materials is a violation of federal law.

10. I am responsible for supervising and supporting Distributors I sponsor into the program and in my commissionable downline. I agree to maintain monthly communication and support to those Distributors in my commissionable downline by way of any of the following, or combination thereof: Personal contact, telephone communication, written communication and attendance at Distributor meetings.

11. Company provides the following fulfillment to Distributor: A New Distributor packet of sales literature. Additional sales materials may be purchased from the Company. The Company will honor literature refund policies provided by any applicable State or Federal law.
